

DECISION OF THE EXECUTIVE COUNCIL :

RESOLVED that the Bajali T.T. College be granted Permanent affiliation upto B.Ed. Course from the Session 2013-14.

- (1) To obtain the NCTE's approval and submit the same to the University for necessary consideration.
- (2) To purchase more text books and reference books for the Library as per Course structure.
- (3) To take initiative to improve the result of the students in the Examination.
- (4) NAAC visit be arrange for ; within 2014.
- (5) To construct the boundary wall to build congenial-academic environment.
- (6) Teachers who don't have M.Ed. Degree must complete M.Ed. degree as per NCTE norms at an early date.

RESOLVED also that the College be informed of the following conditions.

- (i) **Withdrawal of Affiliation** : The Executive Council on the Recommendation of the Affiliation Committee by a resolution shall have the power to withdraw any affiliation or permission from a College at any time. Whenever, if in the opinion of the Executive Council, the College has failed to comply with Statutes, Ordinance, Rules, Regulations or any other directives of the University or the College authorities have failed to maintain order and discipline in the College of the normal and proper functioning of the College has become impossible due to mismanagement of the affairs of the College or for any reason.
- (ii) The Annual fee of Rs. 4500/- (Rupees Four thousand five hundred) per faculty of the College be paid per year by the College.
